WITHDRAWAL OF EAGLE CLIFF SOUTH ADDITION SECTION 4 FROM THE DECLARATION AND OWNER'S CERTIFICATE FOR EAGLE CLIFF SOUTH ADDITION, A RESIDENTIAL COMMUNITY TO THE CITY OF NORMAN, CLEVELAND COUNTY, STATE OF OKLAHOMA

THIS WITHDRAWAL OF REAL ESTATE FROM THE DECLARATION AND OWNERS CERTIFICATE is made on April 8, 2014, Eaglecliff Limited Partnership, an Oklahoma limited partnership ("Declarant")

Section 1 – Recitals.

Declarant is the Declarant of the Eagle Cliff South Addition to the City of Norman, Cleveland County, State of Oklahoma. At Plat Book 23, Page 150, Declarant platted the Eagle Cliff South Addition Section 4. By the filing of a supplementary declaration filed at Book 5252, Page 656 within the Cleveland County Clerk's office (the Supplementary Declaration), Declarant subjected Eagle Cliff South Addition Section 4 to the existing governing documents of the Eagle Cliff South Addition, such documents being recorded at Book 3861, Page 1426 and Book 3862, Page 606 (the Original Governing Documents). Declarant presently owns each of the platted lots within Eagle Cliff South Addition Section 4.

Section 2 – Withdrawal and Revocation.

Section 2.1. Withdrawal of Real Estate. Pursuant to the Declarant's authority under law, and authority and rights reserved and granted within the Original Governing Documents, the Declarant hereby withdraws Eagle Cliff South Addition Section 4, more particularly described within **Exhibit 1** attached and incorporated herein, from subjection to the Original Governing Documents. After the date of recording this instrument, Eagle Cliff South Addition Section 4 shall no longer be subject to the Original Governing Documents.

Section 2.2. Revocation of Supplementary Declaration. For the purpose of effectuating the withdrawal of Eagle Cliff South Addition Section 4 set out under Section 2.1 above, the Supplementary Declaration is hereby revoked.

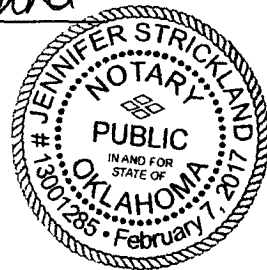
